

# General Conditions of Use (GCU)

Welcome to IntuiConnect! By accessing or using our Services, you agree to be bound by these Terms of Service. If you do not agree to these Terms, please do not use our Service.

## 1. Définitions

- Service: The service is provided by 2makesense via <https://my.intuiconnect.com/>
- User: Any natural or legal person using the Service
- Account: The personalized access assigned to each registered user

## 2. Object

The purpose of these CGU is to define the terms and conditions of use of the Service and the rights and obligations of each party.

## 3. Access to the Service

### 3.1. Creating an account

Use of the Service requires the creation of an account. The User agrees to provide accurate information and to keep it up to date.

### 3.2. Eligibility

The User must be 18 years old or have the authorization of his legal representative to use the Service.

### 3.3. Availability

The Service is accessible 24 hours a day, 7 days a week, except for maintenance or events beyond our control.

## 4. User Obligations

- Use the Service in accordance with the law and these GCU.
- Do not access or attempt to access other users' data without authorization.
- Do not use the Service for fraudulent, illegal or harmful purposes

## 5. Financial conditions

### 5.1. Pricing

Rates are specified on the website. Any changes will be communicated in advance.

### 5.2. Billing

Subscriptions are billed monthly or annually, with the possibility of termination in accordance with Article 9. Any use or sharing of the subscription with a third party or in a mutualized framework requires the prior acquisition of an additional license by the user or the parties concerned.

## 6. Intellectual property

All intellectual property rights related to the Service, including but not limited to software, logos, texts, images, and graphics, belong exclusively to 2makesense.

## 7. Protection of personal data

The personal data collected is processed in accordance with our Privacy policy.

In accordance with applicable legislation, the User has the right to access, rectify and delete their data.

The User is solely responsible for the content that he publishes or shares via the platform. Furthermore, 2makesense cannot be held responsible in the event of:

- Temporary unavailability of the Service.
